**INITIAL DECISION**

**INTRODUCTION AND STATEMENT OF FACTS**

On June 15, 2005, Employee, a Motor Vehicle Operator in the Career Service, filed a Petition for Appeal from the Division of Transportation's (DCPS-DOT) action to separate her from service pursuant to a reduction-in-force (RIF) effective June 22, 2005. However, on June 17, 2005, the Administrator of DCPS-DOT issued a statement canceling the RIF as a result of an agreement reached between his office, the Superintendent of Schools and Employee's Union, Teamsters Local 639. Shortly thereafter, Employee informed this Office that she had not been separated and

therefore wished to withdraw her Petition for Appeal. This matter was assigned to the undersigned Judge on August 8, 2005. The record is closed.

JURISDICTION

This Office has jurisdiction in this matter pursuant to D.C. Official Code §1-606.03 (2001).

ISSUE

Whether this matter may now be dismissed.


ANALYSIS AND CONCLUSION
