## **INITIAL DECISION**

#### INTRODUCTION AND PROCEDURAL BACKGROUND

On July 14, 2015, Robert Kinney ("Employee"), filed a Petition for Appeal with the Office of Employee Appeals ("OEA" or "Office") contesting the District of Columbia Public Schools' ("Agency") decision to terminate him as a Custodian Foreman.
